I will make every effort to give of my time to meet the requirements of this position. I accept my position with the understanding I may not be funded for all or any of my expenses while performing my volunteer duties
- 6. <u>Duty of Diversity, Equity and Inclusion</u>: I will be mindful that I am representing the intentional culture of Women's Council to create a neutral, welcoming and inclusive environment for all.
